11 AN ACT concerning

12 Privately Owned Airplane Landing Strips --

13 Tax Exemption

14 FOR the purpose of exempting from the assessment of real property
15 tax certain privately owned airplane landing strips which are open
16 to the public.

17 BY ADDING:

18 SUBTITLE 10. FINANCE AND TAXATION.

19 Section 10-194.1,

20 The Prince George's County Code

(1987 Edition).

21 SECTION 1. BE IT ENACTED by the County Council of Prince
22 George's County, Maryland, that a new Section 10-194.1 be and the
23 same is hereby added to the Prince George's County Code to read as
24 follows:

25 SUBTITLE 10. FINANCE AND TAXATION.

26 DIVISION 8. TAX ASSESSMENT, LEVY AND COLLECTION.

27 Subdivision 1A. Property Tax.

2 Sec. 10-194.1. Same; Airplane landing strips.

3 (a) All property on which is located essential portions of
4 improved airplane landing strips as certified by the Maryland State
5 Aviation Administration, is hereby exempted from County property tax
6 in accordance with Section 8-302, Tax-Property Article, Annotated
7 Code of Maryland, provided that the landing strip is:

8 (1) Located on privately owned land;

9 (2) Used by the public;

10 (3) Licensed under Title V of the Transportation
11 Article of the Annotated Code of Maryland; and

12 (4) Identified in the Maryland Aviation System Plan
13 as essential to the State's air transportation system.

14 (b) Application and proof of eligibility for exemption
15 shall be filed with the Director of Finance on forms approved by the
16 Director of Finance no later than October 1 of the tax year for
17 which exemption is sought.

18 SECTION 2. BE IT FURTHER ENACTED that the exemption
19 provided in Section 1 of this Act shall be effective beginning with
20 the Tax Year beginning July 1, 1989.

21 SECTION 3. BE IT FURTHER ENACTED that this Act shall take
22 effect forty-five (45) calendar days after the date it becomes law.
