## **Comprehensive And Supplemental Investment Board Of Trustees**

Effective July 1, 2010, the Board of Trustees for each Plan adopted a resolution to establish a Master Trust Agreement to pool assets, *solely for investment purposes*, to increase the available investment options for the portfolios. By pooling all assets, the Plans now meet qualified purchaser and accredited investor status and can consider investments in private equity, hedge funds and real assets. The Master Trust Agreement establishes a sixteen member Board of Trustees comprised of the following offices. (majority = 9)
