In the matter of **t/a G.I. Liquors**, see email dated September 28, 2023, informing the Board that the establishment passed final inspection to reopen. In addition, they are inquiring if the establishment can open on December 24th and 31st since both days are on a Sunday this year. The Commissioners has noted that the establishment passed final inspection to reopen. Per R.R. #41, the Commissioners voted by unanimous consent to allow the opening on December 24th and 31st,2023.

They are currently looking for a new location and will do a Transfer of Location when they find a new location for the liquor store.
