In the matter of t/a JB Atlantic Restaurant & Grill, 9624 Ft. Meade Road, Laurel, 20707. See letter dated February 21, 2025, regarding notification of the restaurant's closure to the public. This decision was prompted by a 60% rent increase imposed by the landlord. Additionally, the passing of their chief accountant and bookkeeper, Mr. Jack Gates, who passed away in November 2024. Mr. James Natty, the licensee, is seeking a temporary hold on his license to organize his records and address any uncertainties before finding a new location to move to. The licensee is actively seeking a new location and will provide an update to the Board upon securing a new location.

The Commissioners voted by unanimous consent to approve the temporary closure of the establishment so the licensee can seek a new location to transfer the license.
