This is in violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animal'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-182 'Potentially Dangerous Animals'; Section 3-185.01 'Pit Bull Terriers.'; Section 3-186 'Vaccination of dogs, cats, and ferrets'.

# **CHARGES:**

The Prince George's County Animal Services Division is requesting an Animal Control Commission hearing regarding four horses from this location. All four animals were reported to be in the care of Robert Stanback. These animals were impounded on October 16, 2024, with the approval of a licensed veterinarian. The horses were impounded due to unsafe living conditions, lack of proper food, water, shelter, one horse being malnourished and declining condition of two other horses. This is in violation of Section 3-131'Manner of Keeping Animals', Section 3-132 'Public Nuisance Conditions'; Section 3-133. Sanitary conditions for care and maintenance of animals; Section 3-135 'Animals at large prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-144. Disposal of an animal carcass; Section 3-165. Riding

school and stable license; and Section 3-180 'Animal Cruelty and Neglect; prohibited' of the Prince George's County Code.

### **CHARGES:**

The City of College Park Animal Control is requesting a Dangerous Dog Hearing due to the two dogs listed above running at large, charging, lunging, and acting aggressively to ACO Bailey and also charging and lunging at pedestrians on Oct 3rd, 2024. This is in violation of Section 3-131, "Manner of Keeping Animals"; Section 3-135 "Animals at Large Prohibited"; Section 3-142 "Irresponsible Pet Owner"; Section 3-136 "Dangerous Animals"; Section 3-182 "Potentially Dangerous Animal"; and Section 3-145 "Ferret, dog, and cat licenses."

The Prince George's Animal Services Division is requesting a non-compliance hearing for the above referenced property/animal owner, Louis, and Cynthia McClam. Mr. McClam was brought before the Commission for Animal Control on May 29, 2024, for a Public Nuisance Hearing. Mr. McClam has failed to comply with the order to include continued nuisance barking complaints and failure to license any dog on the property, supply vaccination records, nor apply for a hobby permit after ACO's confirmed seven dogs on the property on October 9, 2024. This is in violation of the Commission for Animal Control Case No. 11-23. Section 3-131 'Manner of Keeping Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 "Ferret, dog, and cat licenses'; Section 3-148.01 "Animal Hobby Permit"; and Section 3-186 "Vaccination of dogs, cats, and ferrets." of the Prince George's County Code.

#### **GENEVIEVE LUCAS**

### **CHARGES:**

The Prince George's Animal Services Division is requesting a non-compliance hearing for the above referenced property/animal owner, Genevieve Lucas. Ms. Lucas was brought before the Commission for Animal Control on April 10, 2024, for a Vicious Dog Hearing. Ms. Lucas has failed to comply with the vicious dog restrictions most recently on October 22, 2024, two of her dogs "Moe" and "Lucky" were found running at large and entered onto the property of 15471 Baden Westwood and attacked the homeowner's poodle that was loose in its own

yard, causing injury. "Moe" and "Lucky" are currently in the custody at the Animal Services facility. This is in violation of the Commission for Animal Control Case No. 49-23. Section 3-131 'Manner of Keeping Animals'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner' of the Prince George's County Code.

# **CHARGES:**

The Prince George's Animal Services Division is requesting a non-compliance hearing for the above referenced property/animal owner, Gustavo Manzur. Mr. Manzur was brought before the Commission for Animal Control on August 28, 2024, for a Vicious Dog Hearing. Mr. Manzur has failed to comply with the vicious dog restrictions most recently on November 17, 2024, when Lead Animal Control Officer Cooke was sent 12 photos of the dog "Luna" running at large on the 4500 block of Rhode Island Ave. This is in violation of the Commission for Animal Control Case No. 104-24 VA. Section 3-131 'Manner of Keeping Animals'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; of the Prince George's County Code.
