EXECUTIVE ORDER

No. 5 – 2025

March 27, 2025

WHEREAS, Prince George's County Code Section 2-292 (the "Code") provides for the establishment of the Board of Ethics ("Board") and Section 2-298 provides for the establishment of the Office of Ethics and Accountability ("OEA") to exercise the powers contained in Subtitle 2 of the Code; and

WHEREAS, Section 2-294 of the Code requires that elected officials, officials, candidates for office, and designated employees file financial disclosure statements; and

WHEREAS, Section 2-294 further provides that the County Executive, may by Executive Order, designate officials, employees, and/or appointees of the County Government who shall file financial disclosure statements to maintain the highest trust and confidence in public officials and employees serving in County Government; and

WHEREAS, it is in the furtherance of the public trust and to set minimum standards for the conduct of local business that all members of certain boards and commissions disclose all their relevant financial affairs to assure their impartiality and independent judgment; and

WHEREAS, under the authority Section 2-294, Executive Order 13-2014 was issued on April 23, 2014, which designated the officials, employees, and/or appointees of the County Government who are required to file financial disclosure statements; and

WHEREAS, Executive Order 13-2014 also authorized that the list may from time to time be amended by the County Executive or their designee; and

WHEREAS, this Executive Order supersedes prior Executive Order 13-2014.

WHEREAS, the attached list designates the officials, employees and/or appointees of the County Government who are required to file financial disclosure statements; now therefore



Employees identified within the County Executive's Office in a professional or paraprofessional classification, regardless of whether the position is detailed or a temporary assignment, and regardless of their exempt status.

IT IS HEREBY ORDERED, that all officials, employees, and appointees of the County Government who are (1) responsible for making government decisions, policy or taking governmental action pursuant to any such decision or policy or recommending any such decision, policy or action with regard to (a) procurement or contracting, (b) administering or monitoring grants or subsidies, (c) planning or zoning, (d) inspecting, licensing, regulating, or auditing any nongovernmental enterprise, or (e) other activities where the decision, action, or policy might have significant economic impact on the interests of any nongovernmental enterprise, or (2) dependent partly or wholly in their private interest by their association with the County Government, and in the course of their private duties and/or services utilize public equipment, supplies, property, or the influence of their public office, as determined by the Office of Ethics and Accountability, are required to file financial disclosure statements in the same form and manner as set forth in Division 17 of Subtitle 2 of the Code of Ethics; and

IT IS FURTHER ORDERED, that the attached list may from time to time be amended by the County Executive or their designee; and

IT IS FURTHER ORDERED, that this Executive Order shall take effect immediately.
