With increasing market demand of rental property, the investments made by the County in affordable housing are not only helping us to protect and expand quality, safe homes that residents of all incomes can afford, but also play a key role in contributing to the creation and preservation of healthy and inclusive communities where access to opportunity is increased.

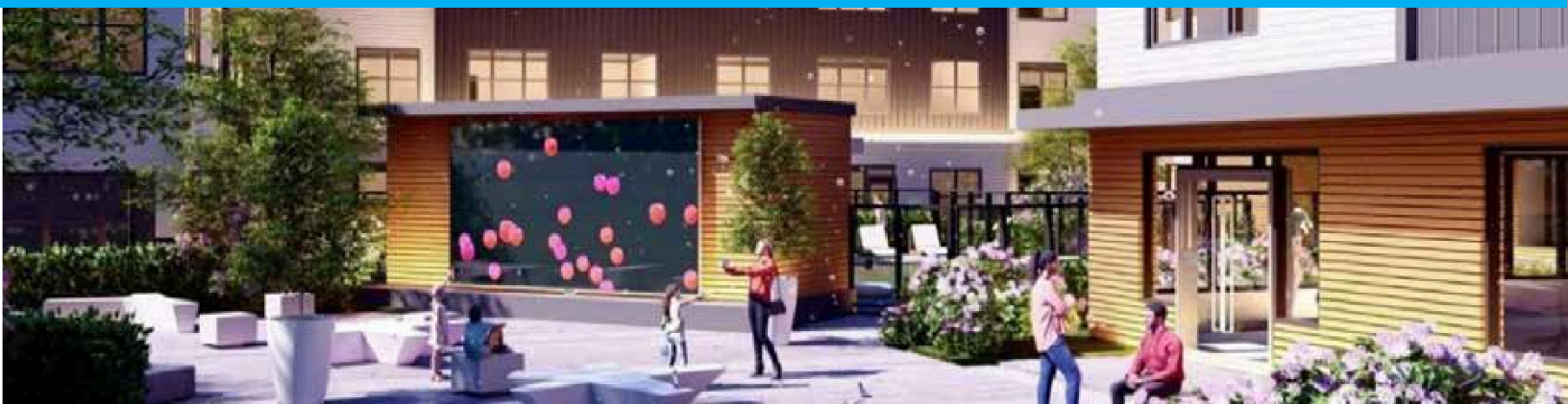

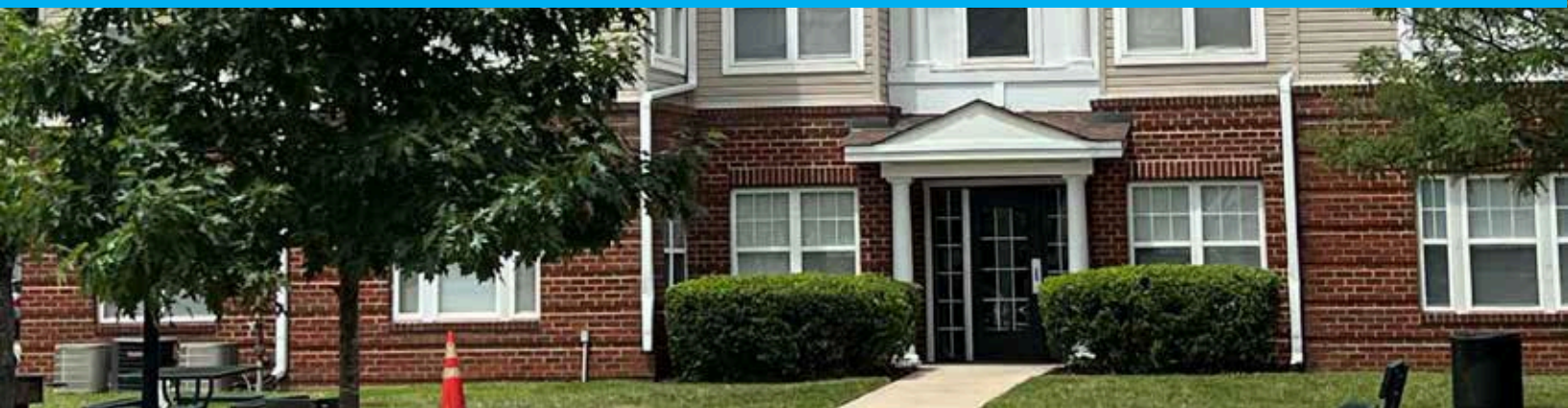

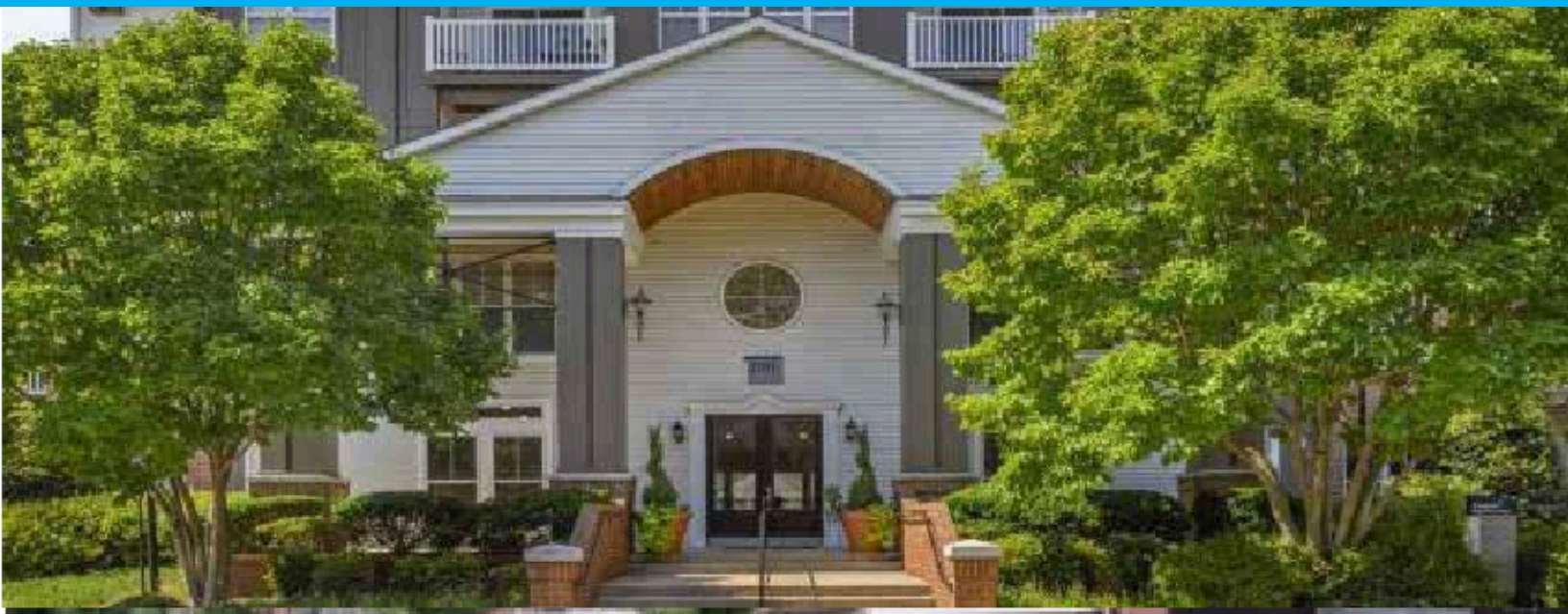

# Right of First Refusal Properties

According to County Resolution CR-51-2015, the County may exercise its Right of First Refusal (ROFR) when an owner of a multi-family rental facility of 20 units or more intends to sell a multi-family property. DHCD has the authority to purchase the property or assign its rights in an effort to stabilize, preserve, and expand housing opportunities for low and moderate income households and increase the availability of quality affordable rental housing in designated areas of the County.

The number of units preserved as affordable varies from one transaction to another. In some instances, a percentage of the property's units are preserved as affordable, wherein other instances, 100% of the units are preserved affordable.
