WHEREAS, the Redevelopment Authority desires to enter into that certain Change in Authorized Signers Form for Commercial Clients (the "Change Form") and that certain Deposit Account and Services Resolution and Authorization for Business Entities ("Resolution and Authorization") with the Bank to update the authorized signatory with the Bank; and

WHEREAS, the Board finds it desirable to grant Ms. West-Spencer the authority to act as a signatory on behalf of the Redevelopment Authority, including, without limitation, with respect to the Accounts.

NOW, THEREFORE, BE IT RESOLVED: that the Board hereby appoints Jacqueline West-Spencer as a signatory on behalf of the Redevelopment Authority, with the full authority to act with respect to the Accounts, and to execute and deliver any documents and agreements reasonably required in connection with the Accounts, including, without limitation, the Change Form and the Resolution and Authorization.
